

## on setting up a separate WLAN network for exhibitors

Dear Exhibitor,

Landesmesse Stuttgart GmbH (LMS) operates a comprehensive WLAN network at the trade fair grounds in Stuttgart which satisfies the latest standards.

If, as an exhibitor, you want to set up a separate WLAN network, then this is subject to registration (5.11 of the Technical Guidelines of LMS) and an application must be made using the order form 10.7 01 (subject to a fee).

As radio networks may affect other exhibitors in the case of uncontrolled configuration, the following rules must be observed - thus ensuring a large frequency range in the WLAN network is available for all users and faults are avoided where possible:

- WLAN transmitters may only operate in the 2.4 GHz area, not in the 5 GHz area.
- The WLAN network must be encrypted (e.g.: WPA2).
- The automatic channel selection must be deactivated
- At events with a high WLAN density you will be assigned a mandatory channel between 1 and 13 until the start of the set-up. If no channel is assigned to you, channels 11 to 13 are to be used.
- Channel bonding is not allowed.
- The emitted transmitting power may only reach a maximum of -80 dBm at the stand boundary.
- The own SSID must comprise the company name and stand number.

WLAN networks can only be set up and used for networking an exhibitor's own stand area. The transmitting power must be adapted for this specific purpose and scope.

Permission may not be granted to third parties to use the network and the operation of unencrypted networks is not allowed.

In the event of faults with other networks and/or with Messe Stuttgart's own WLAN network through a WLAN network operated by an exhibitor or also another transmitter, LMS is entitled to request the exhibitor to make parameter adjustments. and in the event of ongoing interference to shut down the WLAN network.

In the event of non-observance of the above-mentioned guidelines, the entire line (also LAN connections) of the exhibitor may be shut down temporarily or permanently.
