

This includes, among others:

- Fryers
- Deep-fat fryers
- Melting units and devices
- Hot oil baths

Typical household pots and pans are excluded

It is imperative the following information is observed:

1. The units and devices must satisfy the requirements of the Product Safety Act of 01 Dec. 2011.
2. When heating with gas an application must also be made for a licence to operate gas cylinders.
3. The devices/units must only be operated by professional personnel.
4. Ensure through suitable measures (protective devices) that visitors cannot be endangered (e.g. by splashes from hot liquid/mass, etc.).
5. At the end of operation the device/unit must undergo controlled cooling.
6. No harmful overpressure situations can arise through the use of covers and lids.
7. If using water at the stand ensure that also in the event of a leak no water enters the heated medium.
8. The use of CO₂ capsules is not permitted within a radius of 1 m of open heated containers.
9. An appropriate fire extinguisher for grease fire (certified, fire class F, minimum extinguishing capacity 6) must be kept available at the stand.
10. For deep-fat fryers from a total filling capacity of 50 liters, a suitable local fire extinguishing device/system has to be installed.
11. Sprinkler nozzles in the positioning area of fryers or deep-fat fryers would pose an additional hazard for people present in the vicinity if the sprinklers were activated and fryers would get watered. As water has a greater weight, it sinks into hot fat or oil and evaporates immediately, which can cause an oil explosion (steam laced with hot and probably burning fat or oil particles gets ejected from the basin). In addition, a fire propagation cannot be excluded. For this reason, the affected sprinkler nozzles in the positioning areas have to be closed or equipped with an appropriate deflector plate. On uneven ceiling panelling (e.g. coffered ceiling), the deflector plate must be fixed to the sprinkler.
