

Compressed air connections may only be installed by Messe Stuttgart or the designated service partner due to reasons of operational safety and in accordance with the accident prevention regulations.

Exemption can be granted in the following cases up until **6 weeks before the start of the event**:

- The compressor is permanently integrated in the exhibitor's machine and therefore forms an integral part of the machine
- A compressor from the service partner of LMS can only be connected at a higher cost and with major structural modifications which make this connection economically untenable
- The requirement of special gases by the exhibitor which are not to be obtained from the service partner of LMS
- The requirement of special pressures which cannot be supplied by the compressors offered by the service partner of LMS
- Manufacturers of compressors

In the aforementioned exceptional cases, the integrated compressor as well as the integrated compressed air reservoir must be checked and cleared by qualified personnel before start-up in accordance with the current Ordinance on Industrial Safety and Health (BetrSichV) and Technical Regulations on Industrial Safety and Health (TRBS 1203) Part 2 for Pressure Vessels with regard to functionality and operational safety. The inspection and clearance of the integrated compressed air equipment is subject to a charge (see Technical Guidelines of LMS, subsection 5.5.1).
